**ANNUAL REPORT FOR FISCAL YEAR 2023**

Pursuant to the Service Plan for The Highlands Metropolitan District No. 3 (the “District”), the District is required to provide an annual report to the Town of Lochbuie. In accordance with the requirements of § 32-1-207(3)(c), C.R.S., the District hereby provides its’ annual report with regard to the following matters:

- c. The status of the construction of public improvements by the District;
- d. A list of facilities or improvements constructed by the District that were conveyed or dedicated to the Town, the South Beebe Draw Metropolitan District or any other governmental entity;
- e. The final assessed valuation of the District as of December 31 of the report year;
- f. A copy of the current year’s budget;
- g. A copy of the audited financial statements, if required by the “Colorado Local Government Audit Law”, Part 6 of Article 1 of Title 29, or the application for exemption from audit, as applicable;
- h. Notice of any uncured defaults existing for more than ninety (90) days under any debt instrument of the District;
- i. Any inability of the District to pay its obligations as they become due under any obligation which continue beyond a ninety (90) day period;
- j. Boundary changes made or proposed to the District's boundary as of December 31 of the prior year; and
- k. Intergovernmental Agreements with other governmental entities, either entered into or proposed as if December of the prior year.

The District has not issued any Debt instruments, and has not received any notices of uncured events of default under any Debt instrument.

- i. Any inability of the District to pay its obligations as they become due under any obligation which continue beyond a ninety (90) day period.

There was no inability of the District to pay any of its obligations as they came due, in accordance with the terms of any such obligations.

- j. Boundary changes made or proposed to the District's boundary as of December 31 of the prior year.

The District boundaries did not change in 2023.
